THE NRA WIN THIS TRUCK SWEEPSTAKES (“SWEEPSTAKES”) BEGINS AT 12:01 AM EASTERN TIME (“ET”) ON 3/3/25 and ENDS AT 11:59 PM ET ON 1/30/26 (“SWEEPSTAKES ENTRY PERIOD”).

This Sweepstakes includes one (1) Grand Prize Drawing to award three (3) prizes to the grand prize winner and one (1) Fast Entry Prize Drawing to award a single prize to each of five (5) winners.
